Good Afternoon Linda

It was good to meet you on-site on Tuesday (11/04/23)

To summarise our site meeting ;

We established that there's an 11kV pole on your land with associated 11kV overhead conductor crossing the proposed development site.

As discussed we believe it would be beneficial to get some site plans/drawings made to get an idea of the site layout and to establish whether the line would need to be moved, or whether the site layout could work around the electrical assets.

To move or divert the line, my colleague Ollie (who you also met on-site) would need to conduct and overhead line survey to establish what works are required in diverting the line, and possibly gain permission from 3rd party landowners nearby to alter the angle of the stay wires, and pole positions. I would then conduct the design, and quote the costs associated.

We're happy to work with your architect on this when things develop further.

In terms of Electrical connections to the houses, there is Low Voltage network nearby, but whether this would be sufficient will depend on the load required to each individual house when we receive an application form for the connections. An application form can be found on our website at www.nationalgrid.co.uk
